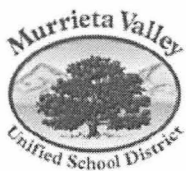
This Compact will be adopted by Tovashal Elementary School and its School Site Council on November 6, 2018 and will be in effect for the period of August 2018 – June 2020.
