MEMORANDUM OF UNDERSTANDING 24/25 - #9

MEA Collective Bargaining Agreement - Appendix B, "Sideline Cheer Stipends"

This Memorandum of Understanding is entered into by and between the Murrieta Valley Unified School District (hereinafter, "District") and the Murrieta Educators Association (hereinafter, "Association") regarding cheer stipends as outlined in Appendix B in the MEA Collective Bargaining Agreement (hereinafter, "MEA CBA").

WHEREAS, the District and Association met during the 24/25 negotiation cycle and revised Appendix B – Stipend Schedule. The parties agree to amend the Sideline Cheer Coach and Assistant Sideline Cheer Coach stipend from a single full year stipend to a per season of sport stipend. The maximum Sideline Cheer stipends available to an employee will be three seasons: Fall, Winter and Spring during a school year. The revision below will be incorporated into Appendix B of the MEA CBA during the next bargaining cycle.



The Parties affirm the obligation to comply with all provisions of the MEA CBA not in conflict with this MOU. Further, the Parties affirm that all provisions of the Educational Employment Relations Act ("EERA") *California Government Codes 3540 et seq.* apply and remain in effect.


The provisions of this agreement shall not be modified and/or changed unless both parties mutually agree. Any alleged violation, misinterpretation, or misapplication of the terms of this agreement shall not be subject to the grievance process.
