E. COMMUNICATIONS

1. Student Representative Reports

Murrieta Mesa High School, student representative Victoria Vollmar, reported on academics, athletics, activities and upcoming events.

Murrieta Canyon Academy, student representative, Gavin Larson, reported on the start of the school year, academics, Phoenix activities, guidance and leadership, and culture and climate.

Vista Murrieta High School, student representative, Taylor Arun, reported on academics, athletics, activities on the Ranch and upcoming events.

Murrieta Valley High School, student representative Meghan Lewis, reported on academics, athletics, activities and upcoming events.

2. Public Comment

Jose Carreno welcomed the newly elected board members and noted that union organizations funded some members' campaigns. He expressed his hope that the board members' votes will prioritize the interests of students and parents over those of the unions.

Carolina Quivoz commented on the redistricting process and the committee's recommendations. She expressed her support for options 1 and 2.

3. Employee Organization Reports

Lisa Murray, President of Murrieta Educators Association, welcomed the board and staff back from winter break. She highlighted the successful professional development day on January 13, 2025. Mrs. Murray emphasized the importance of student and staff safety on campus. She mentioned the District's pilot of the Raptor alert app, which allows staff to quickly summon assistance or initiate a lockdown via mobile devices. Concern was also expressed over the need for an alert app for encounters with irate parents. Ms. Murray stressed that while parents have rights, they do not have a right to bully or harass educators and asked for the Board's commitment to support educators in these situations.

4. Superintendent Report

Superintendent Dr. Ward Andrus reported that today marks the 92nd school day, indicating the halfway point of the school year. He highlighted the benefits of the three-week winter break, noting that it provided valuable downtime for the community. Dr. Andrus spoke about the successful professional development day on January 13th for certificated employees and discussed the district's effective handling of public safety power shutoffs, which had minimal impact on schools. He recognized Sophia Shoemaker as Vista Murrieta's January Student of the Month and congratulated board member Nancy Young for completing the Masters in Governance training by the California School Board Association. Dr. Andrus provided an update on the new facility on Madison Avenue, formerly The Promise Church, that will house the expanded Family Services program. He said that this facility will double the number of preschool classrooms from five to ten and includes a large professional development room. He also mentioned the potential use of the new property for a future transportation yard. Dr. Andrus expressed gratitude to the board and district leadership for their support and vision for the future.

5. Board Member Reports

Student Board member, Sophia Shoemaker, reported on the recent SAC meeting where various topics were discussed, including bathroom maintenance, office hours, grade-level tasks, and CTE Pathways. She said the bathroom discussion centered around the efforts of the maintenance and custodial teams, and then they discussed ways students and leaders could help keep the bathrooms clean. She reported that the group also suggested utilizing office hours to bring guest speakers in

to inform students about different career pathways. Additionally, they discussed counseling and grade-level tasks, such as senior culminating project and JROTC along with expanding CTE Pathways by adding classes like Agricultural Science, welding and construction. Miss Shoemaker expressed gratitude for the opportunity to share student ideas with the board.

Trustee Nicolas Pardue welcomed everyone to the new year and the new board, emphasizing that the board represents the community, parents, taxpayers, and other stakeholders to ensure the best education for students. He praised the Murrieta Valley Unified School District for maintaining high academic standards and excellent programs on a limited budget. Mr. Pardue highlighted the importance of a positive tone and collaboration among board members and the community to face new challenges, including changes to attendance boundaries. He shared his positive experience of visiting Lisa J. Mails and Monte Vista Elementary Schools. Mr. Pardue also mentioned upcoming challenges related to math curriculum, funding issues, and declining enrollment. He expressed his commitment to working with staff to address these challenges and improve communication and respect within the community.

Trustee Christine Schmidt wished everyone a happy New Year. She shared that she has been researching math scores in the state and district, noting the widespread focus on improving these scores. After attending a board member training in December, she recommended the book "The Great Classroom Collapse" by Lance Izumi, which provided insights into the decline in reading and math scores across the U.S. Mrs. Schmidt also met with Joe Parla, Executive Director of Elementary Education, to understand the district's curriculum selection process and expressed her commitment to building her knowledge to be more helpful on the board. She mentioned her interest in curriculum and professional development, given her background as a professional development specialist. Additionally, Mrs. Schmidt has scheduled site visits to all the schools in her trustee area to meet administrators and observe school activities. She recognized Sarah Casey, a teacher at Buchanan Elementary, for receiving a grant to create and update a school garden, and thanked the Maintenance and Operations Supervisor, Vince Barone and his crew for their assistance with the project.

Trustee Nancy Young wished everyone a good evening and hoped they enjoyed their break. Ms. Young reported attending the Reflections Awards night at Murrieta Mesa, a statewide PTA arts program where winners advance to county and state levels. She praised the PTA volunteers and congratulated all participants for their courage. She also attended the Student of the Month breakfast, finding the students' stories inspiring and emotional. She visited Avaxat Elementary and the Family Services Center, noting the impressive coordination of second-grade classes and the restructuring of PE to teach kids how to play well together. Ms. Young highlighted the Family Services Center's offerings of preschool and childcare for children 18 months and up, emphasizing its importance for working parents. Ms. Young mentioned the district's Golden Bell Award for early childhood education from the California School Boards Association. She also praised the Murrieta Rotary Club for sending seventh graders to Pride Camp, a Rotary leadership camp.

Trustee Yvonne Munoz shared her enthusiasm for basketball, particularly the Vista Murrieta Broncos, where her son Cisco attends. She proudly reported that the Broncos won the Nike Tournament of Champions in Arizona in January. Mrs. Munoz also attended the Murrieta Mesa High School Silent Seven Basketball Game, praising Mesa's ASB and leadership group for their creativity and involvement. She mentioned attending the CSBA new trustee training and the upcoming Brown Act training, emphasizing the importance of understanding legal constraints on board members' interactions with the public. Mrs. Munoz acknowledged the outreach from parents and students regarding proposed attendance boundary changes and other issues, reaffirming the board's commitment to their mission of inspiring students to think, learn, and care. She assured the community that she is a safe space for any member seeking support.

Trustee Eleanor Briggs expressed excitement about her second board meeting and shared that community members have been asking about her experience on the board. She described the experience as a "fire hose of information," highlighting the complexity and intricacy of the board's operations. She thanked staff members Darren Daniel, James Whittington, and Dr. Andrus for their support and willingness to answer her numerous questions. Mrs. Briggs emphasized her eagerness to learn and the team's commitment to effective governance. She reported that she has been organizing her calendar and scheduling site visits across the district. Mrs. Briggs said she plans to visit every site with Dr. Andrus to ask questions and learn how to better serve the community.

13. Proposed School Attendance Boundary maps presentation by Woolpert, which will constitute attendance boundary changes for all comprehensive Elementary and Secondary Schools within the Murrieta Valley Unified School District.

Deputy Superintendent Darren Daniel, together with District consultant Andrew Bishop from Woolpert, presented proposed school attendance boundary maps. These maps were created with input from a committee of 20 parents and at least one representative from each school. The new district boundaries for the 2025/26 school year will only affect newly enrolled students, who will attend new schools based on these boundaries. Starting in the 2027/28 school year, existing elementary students will move to middle schools according to the new boundaries. They discussed grandfathering practices to keep older and younger siblings together, especially for interdistrict transfers. They also explained the district's aim to balance school capacities and ensure equitable experiences across all schools. The proposal takes into account the impact of declining enrollment and the need for facility adjustments. The district will continue to prioritize special education students and manage transfer requests based on grade level and program availability. The community survey results showed that option 1 was the most preferred map.

Board Trustees engaged in conversation, asking staff clarifying questions and sharing concerns about increased transportation costs, the validity of enrollment projections and the desire to keep elementary schools under 1,000 students. They also agreed not to make any changes to the current high school boundaries.
